International Student Scientific Symposium - since 2003, the international Student Scientific Symposium "Academic Objectives of Youth: Insights into Economics, Management, Law and Technology" has been organized at Lithuania Business College. The symposium is hosted by the College's Student Representation. In collaboration with the Department of Scientific-Applied Research.

The purpose of the symposium is to encourage youth interest in innovations within the fields of economics, management, law and technology, as well as to develop students' research competencies.

During the symposium, students deliver presentations in English on a chosen topic, following a provided slide template. Presentations can be made either in person at the College or remotely (Online).

Students can also participate in the symposium by submitting articles in English, adhering to a provided template. Submitted articles are reviewed and published in the "Vadyba / Journal of Management".

The best-rated presentations and articles are awarded prizes established by the College. A panel consisting of two lecturers and one member of the student representation evaluates the presentations based on the assessment criteria outlined below.

EVALUATION CRITERIA FOR PRESENTATIONS

Students registered for the symposium present their chosen topic in English either live or remotely (Online) during the event. The presentation must be relevant, engaging, and no longer than 10 minutes. Presentations are evaluated based on the criteria outlined in Table 1.
